Many of you want to know more about pickleball, or need help connecting with others to play. We've heard you loud and clear and want to let you know that throughout the year, the District offers a handful of programs to help advance your pickleball efforts. Lessons provide instruction as well as hands-on play with others to learn the nuances of the sport. Pickleball Mixers are a great way to get lots of play in a couple hours, as well as meet plenty of new people that you can connect with in the future. In the 2021 Community Survey, residents and community members also suggested dedicated pickleball courts as an investment for the future. Building dedicated pickleball courts will take time, planning and community input, so keep an eye out for opportunities to get involved. In the meantime, there are temporary pickleball lines at Bradford Park that can be used and reserved today. The District hopes to make improvements to Bradford Park in 2022 by creating a more accessible and multi-use option with dual lines (tennis and pickleball) being painted as part of a possible resurfacing project in 2022. Stay tuned to the District's budget process which kicks off on Sept. 7 at the Joint Study Session with the Master Association Board. This meeting includes the annual Budget Town Hall where you can come and make your budget suggestion, whether it is pickleball or not! The Only Constant is Change...

Just when you think you have it all figured out...wham...you're blindsided with a change. Thank goodness Ken-Caryl-ites are flexible, nimble, quick to react and adapt, and demonstrate understanding. Whew!

As you may remember last year, we updated our Temporary Sign Posting rules and regulations to be clearer, easier to understand, and to keep up with the times. Well, wouldn't you know it House Bill 21-1310 was recently signed by our governor, and with this new bill comes changes to what and how HOA communities such as Ken-Caryl can govern and restrict signs and flags on private residential properties.

I won't bore you with all the nitty gritty details...those can be found online with the click of a button and a few pecks of the keyboard. I will, however, give you the Cliff Notes version of how this will change the rules and regulations in Ken-Caryl in regard to temporary signage and the display of flags.

With this new bill, an association shall not prohibit any of the following:

a)The display of a flag on a unit owner's property, in a window of the unit, or on a balcony adjoining the unit. The association shall not prohibit or regulate the display of flags on the basis of their subject matter, message, or content; except that the association may prohibit flags bearing commercial messages. The association may adopt reasonable, content-neutral rules to regulate the number, location, and size of flags and flagpoles, but shall not prohibit the installation of a flag or flagpole.

b)The display of a sign by the owner or occupant of a unit on property within the boundaries of the unit or in a window of the unit. The association shall not prohibit or regulate the display of window signs or yard signs on the basis of their subject matter, message, or content; except that the association may prohibit signs bearing commercial messages. The association may establish reasonable, content-neutral sign regulations based on the number, placement, or size of the signs or on other objective factors.

The key takeaway from this new bill is that the Ken-Caryl Ranch Master Association will not be able to regulate the messaging of temporary signs and flags; however, we are partnering with our Architectural Committee to determine what "reasonable content-neutral rules to regulate the number, location, and size of flags and signs" will be in Ken-Caryl Ranch going forward.

Stay tuned for more information regarding what this new bill will mean for Ken-Caryl Ranch and what changes you can expect from the Master Association.

MA Board Summary

On August 17, the Ken-Caryl Ranch Master Association Board held a regular meeting and discussed the following items:

- Brannon Gearhart Park updates were discussed, including sediment samples from the pond, sulfur levels in the soil, the size of the recommended test site and playground updates.
- The Board reviewed recommended updates to the Access to Association Records Policy.
- The following motions passed:
  - o Accept the 2020 Master Association Audit.
  - o Move prairie dogs from an off-site location to the North Hogback Open Space prairie dog relocation site so that the total number does not exceed 150 dogs.
  - o Approve changes to the Conduct of Meetings Policy.
  - o Approve the updated Employee Handbook.
  - o Appoint Dave Seagraves as the Water District liaison.
- Public comment at the meeting addressed topics, including the Brannon Gearhart Park updates.

◆ Bulletin Board

Master Association Board Updating Access to Association Records Policy

Over the next few months, the Master Association Board will be reviewing several major policies to determine if updates should be made. The board discussed changes to the Access to Association Records Policy at the last Board meeting on Aug. 17.

House Bill 1229 was passed in July in Colorado and takes effect in late September. The act increases requirements for disclosure and transparency in the operations of HOAs in common interest communities, including requiring an HOA to maintain and keep available to unit owners, as part of its official records:

- A list of the HOA's current fees chargeable upon sale of a home in the community; and
- Other information currently required to be disclosed annually under existing law, including financial statements, reserve fund balances, insurance policies and meeting minutes.

The Master Association's attorney recommends adding the two new categories created by HB 1229 to the Access to Association Records Policy. The attorney also recommends revising the section addressing records that may be withheld to make it clear that KCRMA withholds certain records as a general policy in the absence of a good reason for disclosure.

The Master Association Board will vote on the proposed policy changes at their Sept. 21 board meeting at 6 p.m. at the Ranch House and via Zoom. # Protecting Your Home from Wildfire

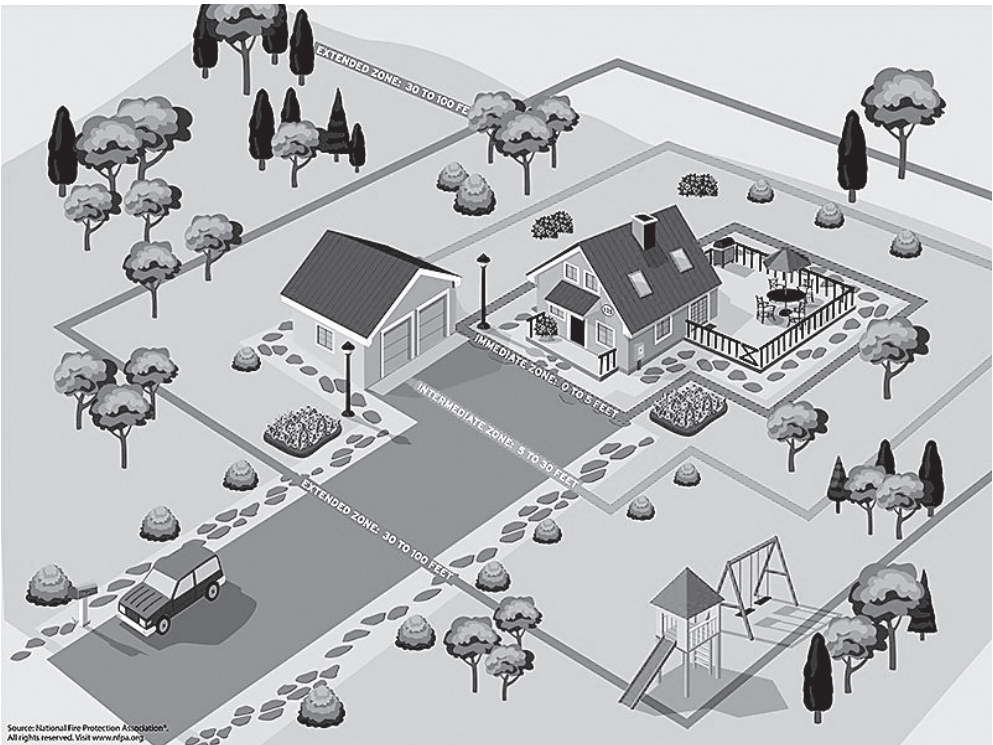
As you can probably tell from the smoky air we have been experiencing over the last month and a half, we are currently in the middle of wildfire season in the United States and in Colorado. Last year, Colorado had the most active fire season in its history, with over 625,000 acres burned and the three largest fires ever recorded in state history. Unfortunately, fire seasons like 2020's will become more common as droughts and heat waves continue to dry out the western United States.

Wildfires in Colorado are inevitable and actually have many benefits to overall forest health and ecological processes. They remove low-growing underbrush, clean forest floors of debris, allow more sunlight to forest floor plants and nourish the soil. However, wildfires pose a serious threat to homeowners living in the Wildland-Urban-Interface (WUI). According to the Colorado State Forest Service, the WUI is "the area where structures and other human developments meet or intermingle with wildland vegetation." As of 2017, 2.9 million people live in Colorado's WUI (about half of Colorado's population), including Ken-Caryl Ranch. As a homeowner in the WUI, it is YOUR RESPONSIBILITY to be aware of the dangers and to actively manage your property to mitigate damage from a wildfire should one occur here.

To protect your home from a wildfire it is important to understand how fire can ignite and destroy your property. Despite what people may think, high-intensity crown fires are not the primary cause of home destruction. There are two main mechanisms for a wildfire to ignite a home. The first is ember intrusion (embers landing on a combustible surface and igniting – keep in mind, embers can travel upwards of one mile from the actual fire site) and the second is low-intensity fire making direct contact with the home. To mitigate these dangers, the concept of the home ignition zone was developed. The home ignition zone includes the structures on your property (house, garage, deck, etc.) and the area surrounding them. The zone is broken up into three different sections: the immediate zone, the intermediate zone and the extended zone (see picture for a visual representation). The following will walk through each zone and provide actionable steps in those zones for a homeowner to take to minimize wildfire threat from embers and heat radiation (low-intensity fires).

## Immediate zone

- This zone includes the home and the area 0-5 feet from the furthest attached exterior part of the home (patios, attached garages, decks, etc.).
- This is the most important zone to take immediate action and is the most vulnerable to embers. You should start with the home itself and then move out from there.
- Actionable steps in this zone:
  - Roofs are the most vulnerable surface to embers.
    - Ensure that your roof is made from non-combustible roofing material
    - Clean roofs and gutters of dead leaves, pine needles and debris that could catch embers
    - Replace or repair loose or missing shingles or roof tiles with non-combustible material
  - Install 1/8-inch metal mesh screening for vents (don't forget about exterior attic vents!) and eaves to reduce embers from passing through
  - Repair or replace window screens and broken windows

- Screen or box in areas below patios and decks with wire mesh to prevent embers from accumulating
- Move flammable material away from wall exteriors (mulch, flammable plants, leaves and needles, firewood, grills, propane tanks, etc.)
- Remove stressed, diseased, dead, or dying trees and shrubs
- Trees/small clumps of trees should have a distance of 18 feet between treetops
- Mature tree canopy should be no closer than 10 feet to the edge of structures

## Intermediate zone

- The area 5-30 feet from the furthest exterior part of the home.
- The goal in this zone is to reduce fuels and to diminish the intensity of the fire as it approaches your home.
- Installing carefully thought-out landscaping, creating breaks and carrying out routine maintenance can help influence and decrease fire behavior in this zone.
- Actionable steps in this zone:
  - Keep lawns and native grasses mowed to a height of four inches
  - Remove ladder fuels (vegetation growing under trees) so a surface fire cannot reach the tops of trees
  - Prune trees 10 feet from the ground (again to reduce ladder fuels)

## Extended zone

- The area 30-100+ feet from structures.
- The goal in this zone is not to eliminate fire, but to interrupt its path and keep flames smaller and on the ground.
- Actionable steps in this zone:
  - Dispose of heavy accumulations of ground litter/debris (please keep in mind that dumping debris in the open space is against rule #5 in our open space rules and regulations, and homeowners can be cited by the Park Ranger staff for doing this. Please dispose of debris in a landfill).
  - Remove dead plant and tree material (again dispose of in a landfill, not the open space)
  - Remove small conifer trees growing between mature trees
  - Remove vegetation adjacent to storage sheds, or other buildings within this area

In addition to these actionable steps in the home ignition zones, residents who border open space are encouraged to mow a 10-foot swath parallel to their property boundary line into the open space. We also approve the removal of woody vegetation that is less than 1 inch in diameter within that 10-foot swath (#5 in the Ken-Caryl Ranch Open Space and Parks Rules and Enforcement Policies). These are two additional actions homeowners should take to minimize the threat of wildfire to their property. Mowing this swath and removing dead woody vegetation has a multitude of benefits. It will lower wildfire fuels immediately surrounding your property, it will lower the risk of snakes and other animals using this area and coming into your property and it will help control noxious weed infestations along home borders (many Colorado noxious weed species increase fire danger. For best results to keep noxious weeds in control, mow every 3-4 weeks from June to September).

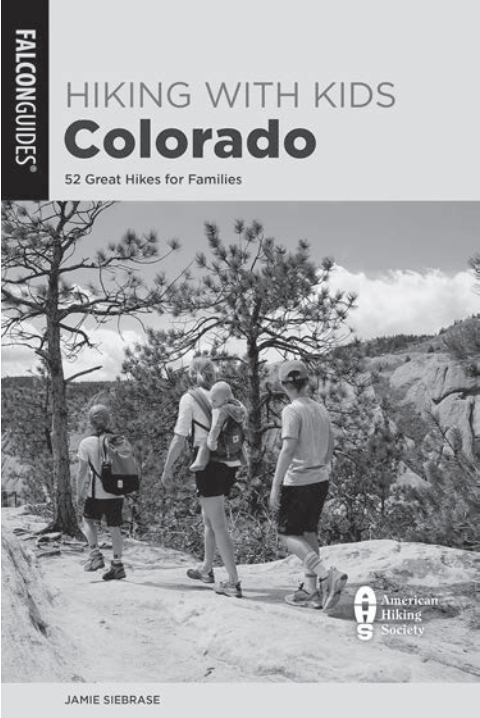
# Resident Jamie Siebrase Combines her Passion for Writing and Hiking with New Book



Carlos opened his shop in February 2020, which serves as the primary source to purchase his throw-back designs.

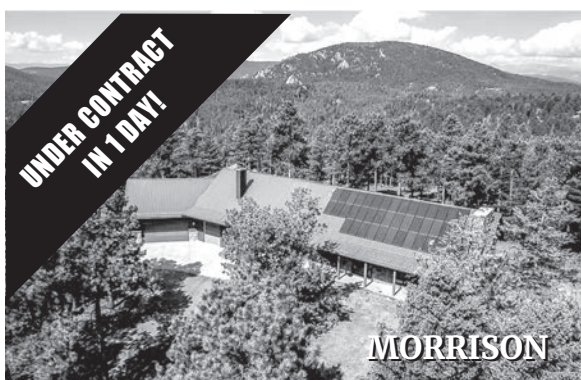

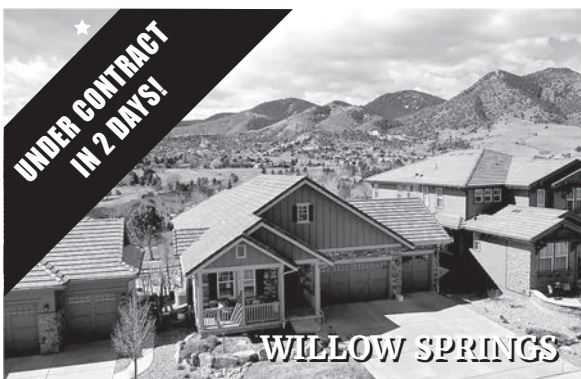

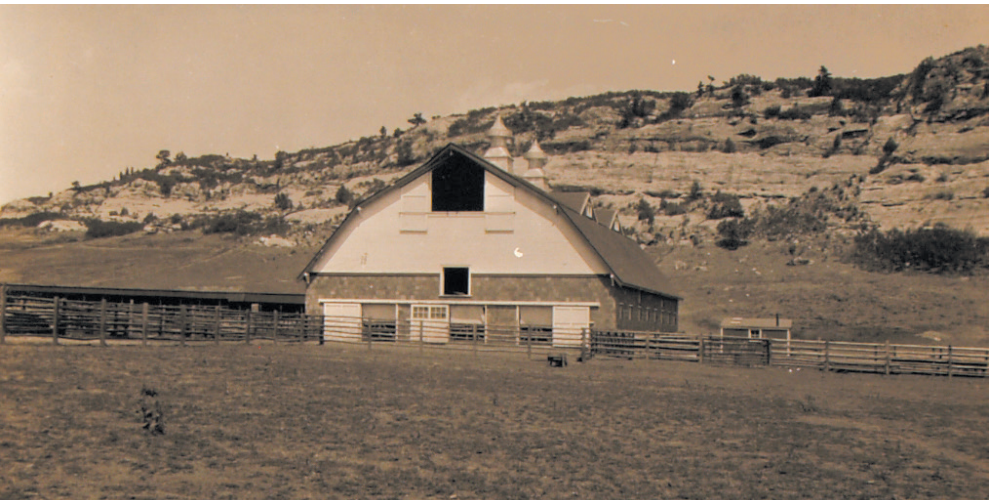

## Shaffer Barn Celebration Sept. 25

Ken-Caryl Ranch residents are invited to attend a celebration of the listing of the John C. Shaffer Barn (also known to residents as the “Main Barn” or “Dutch Barn”) to the National Register of Historic Places. Completed in 1922, the barn was a key component in Ranch-owner John C. Shaffer’s plan to breed exceptional cattle capable of winning national competitions. He was very successful in this pursuit and Ken-Caryl Ranch earned an international reputation for its outstanding Hereford cattle, winning numerous awards. The event will take place on Sept. 25, beginning at 10 a.m. at the Dakota Lodge. There will be a presentation about the 100-year-old barn and why it is unique and qualified to receive the honor of being named to the National Register. This will be followed by guided tours of the nearby barn, including its loft, which is normally closed to the public.

Class 1 e-bikes are allowed on natural surface and paved open space, greenbelt, and park trails. Class 2 e-bikes are only allowed on paved open space, greenbelt, and park trails. Class 3 e-bikes are only allowed on roads and parking lots where motorized vehicles are authorized to travel. However, “Other Power-Driven Mobility Devices” (OPDMD) are allowed on open space, greenbelt and park trails in accordance with “Guidelines for use of OPDMD on properties owned or leased by KCRMD and KCRMA,” which can be found online at [www.ken-carylranh.org](http://www.ken-carylranh.org).

Honoring Fallen Hero and Resident United Flight 93 Captain Jason Dahl on the 20th Anniversary of 9/11

Sept. 11, 2001 has forever left an indelible mark on our country, and especially our community, when Ken-Caryl lost one of its own, Captain Jason Dahl, pilot of Flight 93, which was hijacked at 9:28 a.m. on that fateful day, subsequently crashing at 10:02 a.m. in a field near Shanksville, Pennsylvania, instead of its intended target, the U.S. Capitol Building in Washington D.C. It is believed that the hijackers were subdued by the heroic actions of the passengers and crew on board. In honor of Jason, and the 20th anniversary of 9/11, all residents are invited to attend a candlelight vigil on the evening of Sept. 11 at 7 p.m., to be held at the Jason Dahl Memorial, outside of Jason's former Manor Ridge subdivision, located at the intersection of Valley Parkway and Tamarade Drive.

Family friend, neighbor and Ken-Caryl resident since 1995, Thomas C. Bush, who was also a co-worker of Jason's at United's Denver-based training center and serves as the President of the Captain Jason Dahl Scholarship Fund, fondly reflects on his friendship with Jason and his late-wife, Sandy.

"Jason was an outstanding member of the community and loving husband to his wife Sandy," said Tom. "He lived a Good Samaritan lifestyle, as there are numerous stories about his helping others in need, many of which were total strangers. He was looked up to and respected by all who knew him. On 9/11, Jason and his co-pilot LeRoy Homer made a valiant effort to thwart the terrorist hijackers of United Flight 93, but were overwhelmed in their efforts."

As a tribute to Jason, a memorial was erected by the Manor Ridge sub-association in 2002, and resides right outside of the community's gates, where this year's vigil will be held. In addition, in 2002, the Captain Jason Dahl Scholarship Fund was established to honor Jason's memory and to provide two deserving aviation students a scholarship grant in Jason's name. Originally available to students at Dahl's Alma Mater, San Jose State University and Metro State University in Denver where Jason lived, the program has since been expanded to national status as an IRS recognized 501(c)3 non-profit program supported through corporate and individual donations alike.

"We, at the Dahl Fund, want to honor and pay tribute to Jason and all of the heroes on 9/11 who paid the ultimate sacrifice protecting their country," said Tom. "Our focus is to turn that tragic day into something good by providing scholarships to young aspiring aviators reaching for their dreams."

For those too young to remember the events that forever changed our country on 9/11, retired Bradford K-8 North Principal and board member of the Captain Jason Dahl Scholarship fund, Sam Palamara, created the Heartland Hero Essay program, that has since been implemented across many area schools to recognize everyday heroes.

"Jason's positive personal characteristics were equal to his heroics on 9/11," said Sam. "His wife, Sandy, and Tom Bush saw another way they could impact young people through Jason's example of being an everyday hero. Along with them, I developed an outline for the Heartland Hero Essay Program. Using Jason Dahl's lifetime contributions as a pilot and his caring attitude towards all in his everyday life, we created a writing prompt to inspire

5th grade students to write about their everyday heroes."

Beginning with Bradford's 5th graders in 2011, the Heartland Hero Essay program has expanded to 15 area schools, primarily in the south Jeffco area. According to Sam, more than 1000 students each year write about their everyday hero inspired by Jason's story.

"Memories fade over time and it is important that our young people, many who were not born yet on 9/11, learn about our heroes, their deeds and use them as a standard by which to live by," adds Tom.

On Sept. 11, 2001, Flight 93, piloted by Jason, was brought down in a field by the

passengers and remaining crew in a field in Stonycreek Township, near Shanksville, Pennsylvania, about 80 miles southeast of Pittsburgh and 150 miles northwest of Washington, D.C., killing all on board, including the four hijackers.

Of the four aircraft hijacked on Sept. 11 (the others were American Airlines Flight 11, American Airlines Flight 77 and United Airlines Flight 175), United Airlines Flight 93 was the only one that failed to reach its intended target.

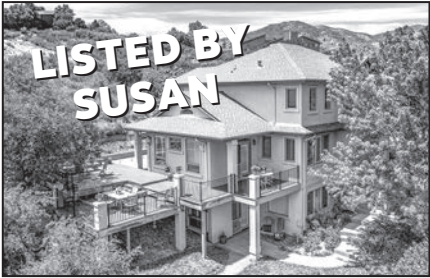
Jason had traded flights with another pilot so that he could take his wife Sandy to London the following weekend to celebrate their fifth wedding anniversary. "With all that has gone on in America,



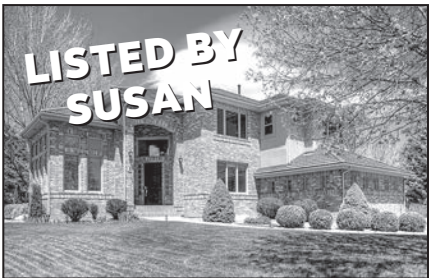

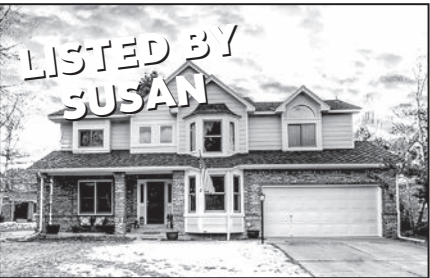

and our community, and continues to go on, it is important to remember those that gave their lives on that day 20 years ago," said friend and former neighbor Kevin Larson." [It is important] to reflect on their sacrifices, and the actions we continue to take to ensure it never happens again. Never forget."

All residents, friends and those who wish to honor Jason are invited to attend the candle light vigil to be held on Sept. 11. Activities will include log book signings and announcements by those who were close friends of Jason. There will be vigil candles available for the first 300 attendees. Activities are scheduled to begin promptly at 7 p.m. and should last for about an hour. There is no parking allowed on Valley Parkway, Tamarade Drive or any of Manor Ridge's privately owned and maintained streets. Attendees may park along White Oak Drive, Buckthorn Drive, Amaranth Drive, or at the Bradford Primary School. All of these areas offer just a short walk to the memorial.

"You never know when you might be called on to stand up for others, or even your country," said Tom. "Jason, the crew and passengers of United Flight 93, were all called on that day. They gallantly stood

up to the terrorists, denying them of their target, our nation's capital. We will be forever thankful for their ultimate sacrifice."

For those unable to attend the vigil on Sept. 11, residents are invited to attend the Heroes of United Flight 93 Remembrance Gala on Oct. 2 from 5-10 p.m. at the Gaylord Rockies Resort and Convention Center in Aurora. The gala, which benefits the Captain Jason Dahl Scholarship Fund and The LeRoy W. Homer, Jr. Foundation, is held every five years and raises money to sponsor future aviators with scholarships. The theme of this year's event is "Heroes are Not Forgotten" and will include a silent auction, followed by dinner, a keynote presentation and a live auction.

To date, the Captain Jason Dahl Scholarship Fund has awarded \$347,000 in scholarships to 178 recipients from 42 schools.

Gala sponsorship opportunities are available, and tickets are currently on sale.

## A Special Remembrance

"Jason was an incurable romantic and was always searching for ways to surprise his wife Sandy with gifts that expressed his love for her. His last attempt was shortly before Sept. 11, 2001. Seems that Sandy had always wanted an area just outside their front door planted with daffodils and was on Jason's to-do project list before winter set in. He kept saying that he would get around to it, but never said when. Then, while she was away from home one afternoon, he secretly recruited friends to plant the entire area Sandy wanted with hundreds of daffodil bulbs. The project was completed and Jason never said a word about it to Sandy, wanting it to be a surprise the next spring. Following Jason's passing, the daffodil planting was totally forgotten by all because of the tragedy of Sept. 11. Then, one morning the following spring, I received a call from Sandy in disbelieving tears of joy describing to me of how she discovered Jason's final act of love for her."

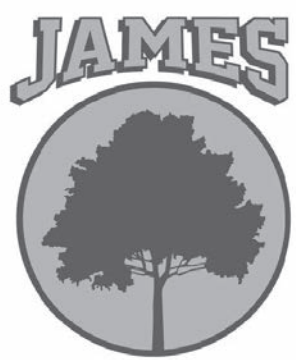

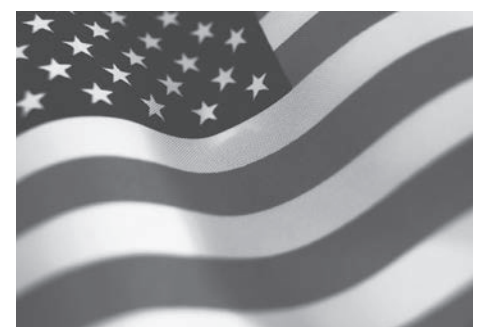
